Welcome to our mid-year edition of the ENplus® newsletter!

We are leaving behind a heating season marked by price increases, tightness in the supply chain and lower demand caused by the warm winter. Nonetheless, even in these challenging times, the use of high-quality pellets remained a must for the majority of end-users that speaks for the confidence in the market.

The evolution of the EN*plus*<sup>®</sup> figures is another clear evidence for that. Despite the termination of the certification of all Russian and Belarusian companies, the certification scheme managed to achieve 13.3 million tonnes of certified pellets in 2022, while the certified production this year is projected to surpass 14 million tonnes.

Additionally, the feedback we received from the certified companies via our dedicated survey earlier this year showed that EN*plus*<sup>®</sup> is appreciated more than ever. According to 82% of the participating certified companies, the EN*plus*<sup>®</sup> certification helps them improve internal quality management, while 4 out of 5 confess that the certification is essential to their

business.

A reminder to all the certified companies who need to update bag designs and submit them for reapproval before the end of 2023. All bag designs that have been approved before the publication of the new documentation (1.10.2022) need to be updated to meet the new requirements and submitted for reapproval.

All certified companies should comply with the new set of requirements introduced with the EN*plus*<sup>®</sup> revision by 1.1.2024. Check out this document or have a look at this brochure to see what changes were made or read the full documentation here.
