




Monthly Update

Changes brought by the scheme's revision

Certified companies must establish and maintain a mass balance account for production/procurement and all sales transactions of all pellets. These requirements alongside the requirements for delivery documentation on sold pellets provide the basis for chain of custody requirements, ensuring that the company is not selling more EN*plus*[®] certified products than it has produced or procured. 

The EN*plus*[®] Management organises the Market Surveillance Project - an initiative that aims to analyse EN*plus*[®] certified bags randomly taken from the market in order to assure compliance with the EN*plus*[®] standards. Anyone can contribute to the project by submitting a sample via this form.
