The reduced VAT rate of pellets in Italy ended and now it is back to 22%. Meanwhile, Portugal, Romania and Spain keep their reduced rates of 6%, 5% and 5% respectively, with Spain expected to put an end to it in June 2024.

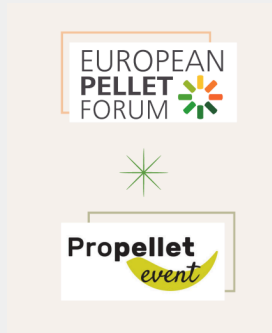
