More than a Decade with Us

The bag design of certified pellets must include a serial number that allows identification of the company that bagged the pellets, the site of the bagging, and the date of the bagging. Certified companies are free to choose the format of the serial number as long as it includes the mandatory 3 types of information and is permanently printed. However, they must introduce it on the pellet bag no later than 1st January 2025. Information on the topic is provided in the document ST 1003.

Do you know?

The European Commission proposed a delay of EUDR (EU Deforestation Regulation) that was approved by the Council. If approved by the European Parliament, it would make the law applicable on 30 December 2025 for large companies and 30 June 2026 for micro- and small enterprises. Learn more here.
