Europe's 2040 climate target requires 80 million tonnes of industrial carbon removals per year. BECCS, Bioenergy with Carbon Capture and Storage, can make this goal a reality. According to the study, by upgrading just 38% of existing biomass installations, Europe could already deliver those 80 Mt of carbon removals, assuming a 95% capture rate.
