

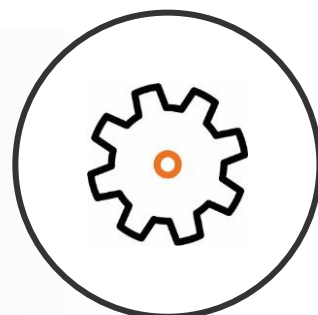

Page 7, Clause 2, Normative references

Add:

“IAF MD 4:2022, IAF Mandatory Document for the Use of Information and Communication Technology (ICT) for Auditing/Assessment Purposes

IAF ID 3:2011, IAF Informative Document For Management of Extraordinary Events or Circumstances Affecting ABs, CABs and Certified Organizations”

Page 18, clause 6.2.3

Replace the text with the following:

“The ENplus® certification body shall only outsource inspection activities defined in chapter 7.3.2 to an ENplus® inspection body that is accredited in accordance with Annex A (A.2) of this standard.”

Page 28, clause A.1.1

Add:

“Note: Documents applicable to certification bodies adopted by the European co-operation for Accreditation (EA) or the International Accreditation Forum (IAF) such as IAF MD 4:2022 and IAF ID 3:2011 are also an integral part of the ENplus® scheme requirements.”
