The Radix Tree dashboard

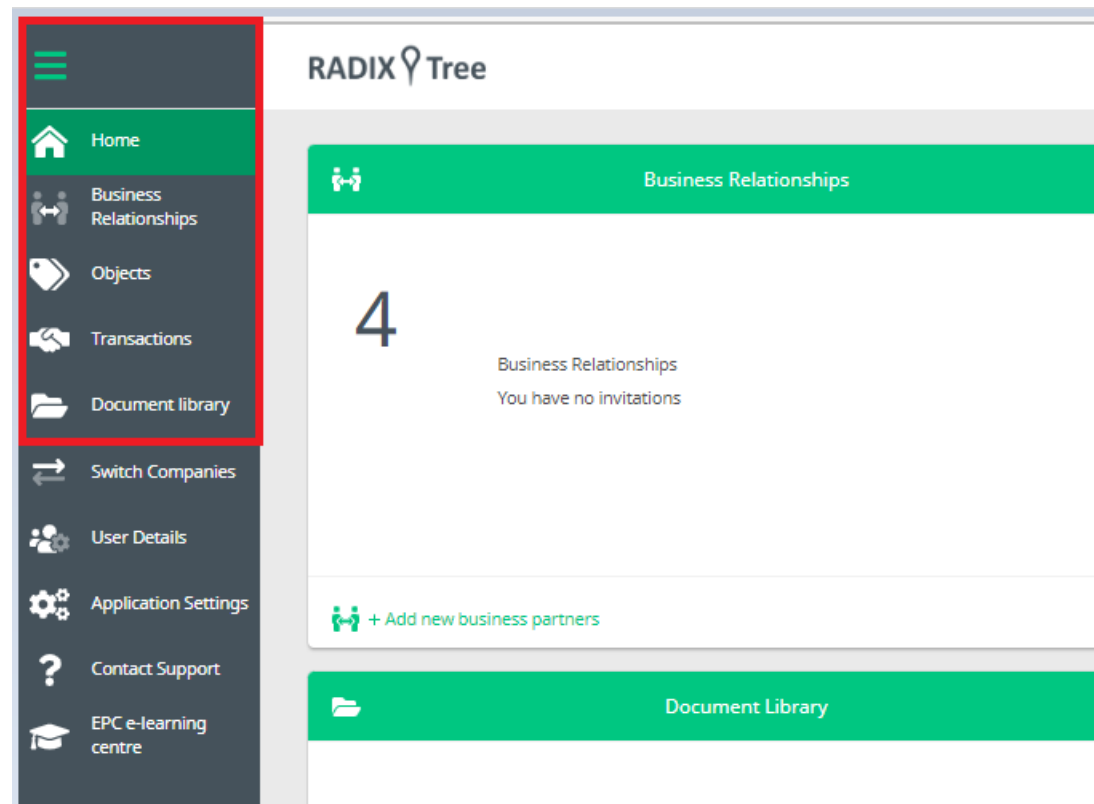
- Once a user is registered, the home page for RADIX Tree is referred to as the dashboard.
- From here all operations and functions can be performed for all users permitted to do so.

The Dashboard – Menu

Fonctions principales

- Business Relationships – This view shows you all the companies directly connected to your business (e.g., your National Licenser, Certification Body).
- Objects - This view is for annual figures, where Traders and Producers will record their annual actual and estimate data.
- Transactions – The transaction library is used to exchange object data between connected companies.
- Document library – The Document Library is where you can find documents relevant for the ENplus® scheme (e.g., Standards).



The Dashboard – Menu

Fonctions administratives

- User details - This function allows you to: view the list of defined users for your company (Quality Manager, accountant, CEO etc.), add a new user (there is no restriction to the number of users), select or remove a user, disable a user
- Application settings - Application settings is where the domain administrators for each company can configure many behaviours of RADIX Tree.
- Contact Support - Contact support is for RADIX Tree issues ONLY. It should be used to raise problems or questions that are not answered in the RADIX Tree FAQ, or training material

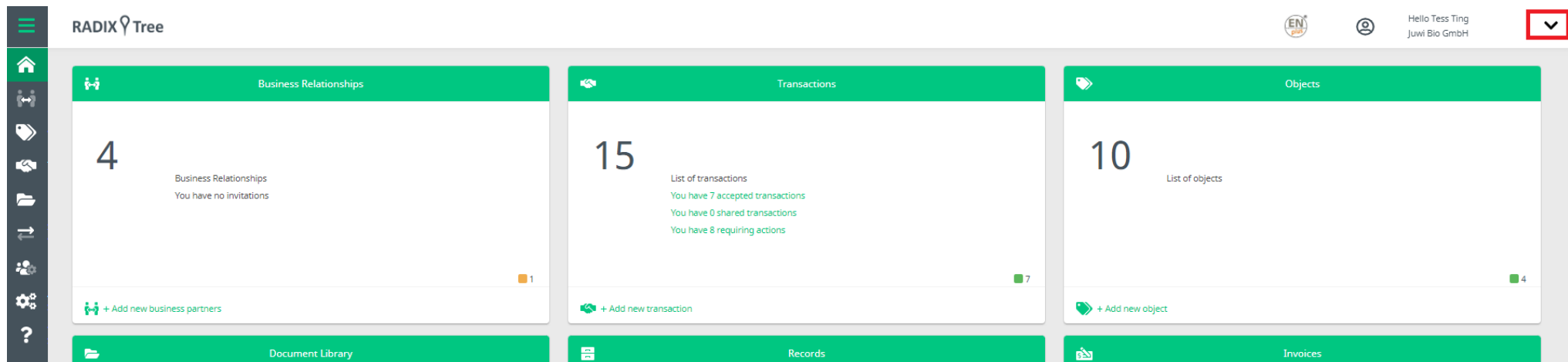
